**NOTICE OF MAYOR'S BRIEFING**

CITY COUNCIL CHAMBERS – 4:30 P.M.**

**A. OUTLINING, ACCEPTANCE OF, OR ANSWERS TO COUNCIL QUESTIONS ABOUT ORDINANCES 129-2025 AND 37-2024; THEIR DISTINCTIVE FEATURES; AND THE CONTROVERSIES RELATIVE TO WHETHER ONE OR ANOTHER WOULD:**

- Deny citizens the right to vote, or enable any impermissible violation of the Equal Protection Clause, most particularly by a failure to adhere to the legal principles upholding the “one person, one vote” rule.
- Relatedly, dilute citizens’ voting power (impinging on the right to vote) by improper gerrymander, racial discrimination, or other protected class discrimination in the drawing of districts.
- Deny access to the ballot in drawing districts intentionally to make the act of voting more difficult.
- Fail to consider cultural and other common ties for districts that create compactness and contiguity. More specifically, whether
  - **Contiguity:** All parts of a district are connected to each other geographically.
  - **Compactness:** Districts have a geographically consolidated area and a regular, smooth shape, avoiding a sprawling or strange appearance.
  - **Preservation of Precincts:** Districts minimize the splitting of precincts; and,
  - **Preservation of Communities of Interest:** The Council made genuine efforts to maintain and genuinely consider neighborhood continuity (with minimal disruption to areas having common social, cultural, historical, or economic interests); and
- Allow candidates to pick voters instead of voters electing candidates (*i.e.* through excessive/unreasonable protection of incumbency *versus* appropriate respect for incumbency choices by communities of interest); and
- Require correction or consideration of information placed in the public record about the relevant history of the aims of a particular plan (*i.e.* whether disputes are political or legal).

Requests to speak shall be strictly confined to the following specific three (3) topics and shall not be redundant: (i) racial disparities or dilution of voting power caused by the redistricting affecting minority voters; (ii) compactness and contiguity issues; or (iii) correcting information placed in the recorded proceedings. Persons may receive direct comment from the Mayor *at this briefing*. As provided by written policy, public comment requests may raise any other (non-agenda) issues if provided in accord with our policy; however, those requests may not be addressed December 8-9, 2025, but may be addressed, as provided in the published policy, at another briefing.
